It is the responsibility of each exhibitor to have the cats at the  
judges table/BIS in due time. Please use your own sturdies if  
possible and list it at the online entry form. Exhibitors are  
responsible to disinfect their own cages. We reserve for each cat a  
space of 70x70 cm, any sturdy larger than that counts as a  
double sturdy and is billed accordingly.

Participation is at your own risk. Recourse claims cannot be  
asserted. HEC e.V. assumes no liability for damage, including  
damage to persons caused by cats exhibited.

## Impfbestimmungen / Veterinary Conditions.

A valid vaccination against rabies is mandatory. The cat has to be  
at least 3 month old at the time of the basic immunization against  
rabies and a period of 21 days has passed since then. The period  
of validity depends on the respective admission of the vaccination  
manufacturer. If it is longer than 1 year, it must be noted by the  
vaccinating veterinarian. All exhibitors, EU and contracting states  
must have the EU pet ID card and transponder identification  
(Microchip). In addition, vaccination against Feline  
Panleukopenie and Feline Rhinotracheitis is mandatory. The  
type of vaccine used determines how long the vaccine is  
valid for. An audiometric hearing certificate for white cats of  
all breeds is required.
